

Layout for CY 2025 Final Rule Ambulatory Surgical Center (ASC) Payment System Supplier Specific File

These supplier level data are abstracted from an internal file used to calculate the budget neutrality adjustments for the final CY 2025 ASC Payment System. This file contains data for ASC services billed in CY 2023 that were eligible to receive payment under the ASC Payment System. We used these CY 2023 claims, along with CY 2024 payment rates and wage indices and final CY 2025 payment rates and wage indices, to model payment under the CY 2024 ASC Payment System¹ and the final CY 2025 ASC Payment System.

Note: This file should not be used to determine an ASC's CBSA, wage index, or enrollment. In this file, CBSA is estimated from mapping the ASC billing zip code to a county and mapping such county to the appropriate CBSA.⁴ In certain rare instances, the zip code-to-county mapping file may incorrectly map an ASC to a nearby county which may be incorporated in a different CBSA than the correct county. Additionally, newly-enrolled ASCs are not captured in this file.

A	Part B MAC Number	Medicare contractor that processes claims for ASC.
B	National Provider Identification (NPI) Number	Supplier identification number. ¹
C	Allowed Services	The total number of services that we estimate a supplier would be allowed to bill for under the CY 2025 ASC Payment System without application of the multiple procedure discount. ²
D	Final CY 2025 ASC Wage Index	Estimated CY 2025 Pre-floor and Pre-reclassification ASC wage index subject to 5% cap assigned by core based statistical area (CBSA).
E	Core Based Statistical Area for Wage Index assignment (CBSA)	Estimated labor market area assignment for purposes of assigning the ASC wage index.
F	Supplier County	Estimated FIPS code county level designation for supplier based on billing ZIP code of facility.
G	State	State abbreviation.
H	Estimated CY 2025 ASC Payments	CY 2025 aggregated payment to supplier. This number is wage adjusted by the proposed CY 2025 wage index to reflect differences in labor market areas. Calculated aggregated payments are represented in whole dollars with no cents.
I	Estimated CY 2024 ASC Payments	CY 2024 aggregated payment to supplier. This number is wage adjusted by the CY 2024 wage index to reflect differences in labor market areas. Calculated aggregated payments are represented in whole dollars with no cents.
J	Region	CMS region of country supplier is located.
K	Part B MAC State	Medicare contractor area/name that processes claims for ASC.
L	Discounted Allowed Services	The discounted number of services that we estimate a supplier would be allowed to bill for under the ASC payment system. ³

¹ In our calculation of aggregate payment to suppliers, we revised 2023 HCPCS codes (where appropriate) to their 2025 status and description using internal 2023-2024 and 2024-2025 crosswalk files.

² In past files we created the supplier identifier values by concatenating the carrier number and provider identification number variables. This identifier has now been replaced by the NPI number.

³ Most covered surgical procedures are subject to a 50 percent reduction in the ASC payment for the lower-paying procedure when more than one procedure is performed in a single operative session.
