

CY 2024-25 Medicare Parts C and D Annual Calendar

Below is a calendar listing of key dates and timelines for activities that pertain to contract years (CY) 2024 & 2025 Medicare Advantage (MA) plans, Medicare Advantage-Prescription Drug (MA-PD) plans, Prescription Drug Plans (PDPs), Medicare-Medicaid Plans (MMPs), and cost-based plans. The calendar provides important operational dates for all organizations such as the date bids are due to CMS, the date that organizations must inform CMS of their contract non-renewal, and dates for beneficiary mailings.

***Note: The dates listed under Part C are pertinent for MAOs include MA and MA-PD plans. The dates listed under Part D apply to MA-PDs, standalone PDPs, MMPs (through the end of 2024) and cost-based plans offering a Part D benefit.**
