SNF QRP Annual Payment Update Warning Edits

Section 1888(e)(6)(B)(i)(II) of the Improving Medicare Post-Acute Care Transformation Act of 2014 (IMPACT Act of 2014) amended the Social Security Act requiring that SNFs submit data, including data on quality measures. SNFs that fail to submit such data are subject to a 2 percentage point reduction to their Annual Payment Update. In turn, CMS established a data completion threshold for such data reporting. SNFs must report 100 percent of the data elements necessary to calculate the SNF QRP measures, as well as standardized patient assessment data elements, on at least 80 percent of the Minimum Data Set (MDS) assessments they submit for the program year involved. SNFs that do not meet this requirement are subject to a two percent reduction in their Annual Payment Update.

To assist SNFs, CMS is excited to announce new Skilled Nursing Facility (SNF) Annual Payment Update (APU) warning edits are being incorporated into the MDS technical submission specifications. These warning edits appear as both pop-up messages in jRAVEN, the free CMS software that allows SNFs to submit MDS data to CMS in the proper format, and also on the MDS 3.0 Final Validation Report (FVR). The edits will appear when required standardized patient assessment data elements and data elements required for quality measure calculation for the purposes of the SNF QRP are dashed. These warning edit will display on FVR as error identification numbers:-3897, -3907 or -3908. Warning edits do not prevent MDS 3.0 assessment from being accepted by the Assessment Submission and Processing (ASAP) system.

A staggered release of the items associated to the APU warning edits is planned, at the completion of this process all APU required data elements will trigger a warning edit. The first release of warning edits was implemented on September 9th, 2018. Future releases of warning edits will be announced here. Attention SNF Providers: Inaugural Release of SNF QRP Data on NH Compare

In accordance with Section 1899B(g)(1) of the Social Security Act, which requires CMS to provide for the public reporting of SNF provider performance on the quality measures, CMS is announcing the inaugural release of the Skilled Nursing Facility (SNF) Quality Reporting Program (QRP) quality data on Nursing Home (NH) Compare.

Nursing Home Compare allows you to find and compare SNFs that are certified by Medicare and nursing homes that are certified by Medicaid. This website contains quality of resident care and staffing information for more than 15,000 nursing homes around the country, and will now additionally include SNF QRP quality data that can be used to compare SNF providers by their performance on important indicators of quality, such as the percentage of patients with new or worsening pressure ulcers, or the percentage of patients that experienced a fall and sustained a major injury. Non-compliance notifications are in the process of being mailed by the Medicare Administrative Contractors (MACs) and will be placed into facilities' CASPER folders in QIES on July 9, 2018. Facilities that receive a letter of non-compliance may submit a request for reconsideration to CMS **via email no later than 11:59pm PST, August 7, 2018**. If you receive a notice of non-compliance and would like to request a reconsideration, see the instructions in your notification letter and on the [SNF Quality Reporting Reconsideration and Exception & Extension webpage](#).

SNF Quality Reporting Program (QRP) Quality Measure (QM) Reports Available

Skilled Nursing Facility (SNF) providers were notified by CMS April 13, 2018, that the SNF QRP reports (SNF QRP Facility- and Resident-Level Quality Measure and SNF Review and Correct) would be unavailable in the CASPER Reporting application while corrections were being made. Duplicate stays were mistakenly being included in the calculations for all three reports when a correction record for a previously accepted record was accepted into the Assessment Submission and Processing (ASAP) system. Additionally, invalid Admission Dates were displaying on the SNF QRP Resident-Level Quality Measure report for the duplicated row.

The three measures affected by the issue are as follows:

- Percent of Residents or Patients with Pressure Ulcers That Are New or Worsened (Short Stay) NQF #0678
- Application of Percent of Residents Experiencing One or More Falls with Major Injury (Long Stay) NQF #0674
- Application of Percent of Long-Term Care Hospital (LTCH) Patients with an Admission and Discharge Functional Assessment and a Care Plan that Addresses Function NQF #2631

Please be advised that this issue has been resolved and the SNF QRP Facility- and Resident-Level Quality Measure and SNF Review and Correct reports are once again available in the SNF Quality Reporting Program report category in the CASPER Reporting application.

Data for the above measures have been recalculated to exclude the duplicated records and the correct Admission Date is displaying on the SNF QRP Resident-Level Quality Measure reports.

Hurricane Nate - Disaster Exceptions/Exemptions for Medicare Certified Providers Affected by Severe Storms and Flooding

The Centers for Medicare & Medicaid Services (CMS) is granting exceptions under certain Medicare quality reporting and value-based purchasing programs to acute care hospitals, inpatient psychiatric facilities, skilled nursing facilities, home health agencies, hospices, inpatient rehabilitation facilities, long-term care hospitals, renal dialysis facilities, ambulatory surgical centers as well as Merit-Based Incentive Payment System (MIPS) eligible clinicians located in areas affected by Hurricane Nate. These healthcare providers and suppliers will be granted exceptions without having to submit a request if they are located in one of the counties listed in the memo posted on [February 8, 2018](#), all of which have been designated by the [Federal Emergency Management Agency \(FEMA\)](#) as a major disaster county.

The scope and duration of the exception under each Medicare quality reporting program is described in the memo as well, however, all of the exceptions are being granted to assist these providers while they direct their resources toward caring for their patients and repairing structural damages to facilities.

If FEMA expands the current disaster declaration to include additional counties, CMS will update this memo to expand the list of providers eligible to receive an exception without submitting a request.

In addition, CMS will continue to monitor the situation and adjust exempted reporting periods and submission deadlines accordingly.

California Wildfires - Disaster Exceptions/Exemptions for Medicare Certified Providers Affected by Severe Storms and Flooding

The Centers for Medicare & Medicaid Services (CMS) is granting exceptions under certain Medicare quality reporting and value-based purchasing programs to acute care hospitals, inpatient psychiatric facilities, skilled nursing facilities, home health agencies, hospices, inpatient rehabilitation facilities, long-term care hospitals, renal dialysis facilities, ambulatory surgical centers as well as Merit-Based Incentive Payment System (MIPS) eligible clinicians located in areas affected by the California wildfires (FEMA [DR-4353](#)). These healthcare providers and suppliers will be granted exceptions without having to submit a request if they are located in one of the California counties listed in the memo posted on [February 8, 2018](#), all of which have been designated by the [Federal Emergency Management Agency \(FEMA\)](#) as a major disaster county.

The scope and duration of the exception under each Medicare quality reporting program is described in the memo as well, however, all of the exceptions are being granted to assist these providers while they direct their resources toward caring for their patients and repairing structural damages to facilities.

If FEMA expands the current disaster declaration to include additional counties, CMS will update this memo to expand the list of providers eligible to receive an exception without submitting a request.

In addition, CMS will continue to monitor the situation and adjust exempted reporting periods and submission deadlines accordingly.
